

PRIVACY POLICY

School aid network's Privacy Policy is designed to help you understand how we collect and use the personal information you decide to share, and help you make informed decisions when using School aid network, located at www.schoolaidnetwork.co.uk and its directly associated domains.

By using or accessing School aid network, you are accepting the practices described in this Privacy Policy.

The Information We Collect

When you visit School aid network you provide us with two types of information: personal information you knowingly choose to disclose that is collected by us and Web Site use information collected by us as you interact with our Web Site.

When you register with School aid network, you provide us with certain personal information, such as your name, your email address, your contact details and any other personal or preference information that you provide to us.

When you enter school aid network, we collect your computer's IP address. This information is gathered for all users. In addition, once logged in, we store certain information in your browser using "cookies". A cookie is a small piece of data stored in a user's web browser which identifies them to the website which originally stored it. This "cookie" stores your user id but not your password or any other personal information. We use session cookies which expire when a user closes their browser window.

When you use School aid network, you may set up your personal profile, form relationships, send messages, perform searches and queries, form groups, set up events, add applications, and transmit information through various channels. We collect this information so that we can provide you the service and offer personalized features. In most cases, we retain it. When you update information, we usually keep a backup copy of the prior version for a reasonable period of time to enable reversion to the prior version of that information.

You post User Content (as defined in the School aid network Terms of Use) on the Site at your own risk. Please be aware that no security measures are perfect or impenetrable. We cannot control the actions of other Users with whom you may choose to share your pages and information. Therefore, we cannot and do not guarantee that User content you post on the Site will not be viewed by unauthorized persons. We are not responsible for circumvention of any privacy settings or security measures contained on the Site. You understand and acknowledge that, even after removal, copies of User Content may remain viewable in cached and archived pages or if other Users have copied or stored your User Content.

Any improper collection or misuse of information provided on School aid network is a violation of the School aid network Terms of Service and should be reported to privacy@schoolaidnetwork.co.uk

By using School aid network, you are consenting to have your personal data transferred to and processed in the United Kingdom.

Use of Information Obtained by School aid network

When you register with School aid network, you create your own profile. Your profile information, are displayed to people in the networks. We may occasionally use your name and email address to send you notifications regarding new services offered by School aid network that we think you may find valuable.

Profile information is used by School aid network primarily to be presented back to and edited by you when you access the service and to be presented to others permitted to view that information.

School aid network may send you service-related announcements from time to time through the general operation of the service.

School aid network may use information in your profile without identifying you as an individual to third parties.

Sharing Your Information with Third Parties

School aid network is about sharing information with others. We allow you to choose the information you provide to other users through School aid network. We do not provide contact information to third party marketers without your permission. We share your information with third parties only in limited circumstances where we believe such sharing is 1) reasonably necessary to offer the service, 2) legally required or, 3) permitted by you. For example:

- We occasionally provide demonstration accounts that allow non-users a glimpse into the School aid network world. Such accounts have only limited capabilities (e.g., messaging is disabled) and passwords are changed regularly to limit possible misuse.
- We may be required to disclose user information pursuant to lawful requests, such as subpoenas or court orders, or in compliance with applicable laws. We do not reveal information until we have a good faith belief that an information request by law enforcement or private litigants meets applicable legal standards. Additionally, we may share account or other information when we believe it is necessary to comply with law, to protect our interests or property, to prevent fraud or other illegal activity perpetrated through the School aid network service or using the School aid network name, or to prevent imminent bodily harm. This may include sharing information with other companies, lawyers, agents or government agencies.
- We let you choose to share information with marketers or electronic commerce providers through opt in/out functionality in your user profile.
- We may offer stores or provide services jointly with other companies on School aid network. You can tell when another company is involved in any store or service provided on School aid network, and we may share customer information with that company in connection with your use of that store or service.
- If the ownership of all or substantially all of the School aid network business, or individual business units owned by School aid network., were to change, your user information may be transferred to the new owner so the service can continue operations. In any such transfer of information, your user information would remain subject to the promises made in any pre-existing Privacy Policy.

When you use School aid network, certain information you post or share with third parties. All such sharing of information is done at your own risk. Please keep in mind that if you disclose personal information in your profile or when posting comments, messages this information may become publicly available.

Links

School aid network may contain links to other websites. We are of course not responsible for the privacy practices of other web sites. We encourage our users to be aware when they leave our site to read the privacy statements of each and every web site that collects personally identifiable information. This Privacy Policy applies solely to information collected by School aid network.

Third Party Advertising

Advertisements that appear on School aid network are sometimes delivered (or "served") directly to users by third party advertisers. They automatically receive your IP address when this happens. These third party advertisers may also download cookies to your computer, or use other technologies such as JavaScript and "web beacons" (also known as "1x1 gifs") to measure the effectiveness of their ads and to personalize advertising content. Doing this allows the advertising network to recognize your computer each time they send you an advertisement in order to measure the effectiveness of their ads and to personalize advertising content. In this way, they may compile information about where individuals using your computer or browser saw their advertisements and determine which advertisements are clicked. School aid network does not have access to or control of the cookies that may be placed by the third party advertisers. Third party advertisers have no access to your contact information stored on School aid network unless you choose to share it with them.

This privacy policy covers the use of cookies by School aid network and does not cover the use of cookies or other tracking technologies by any of its advertisers.

Security

School aid network takes appropriate precautions to protect our users' information. Your account information is located on a secured server behind a firewall. When you enter sensitive information (such as credit card number or your password), we encrypt that information. Because email and instant messaging are not recognized as secure communications, we request that you not send private information to us by email or instant messaging services. If we make changes, we will post them and will indicate at the top of this page the policy's new effective date. If we make material changes to this policy, we will notify you here, by email, or through notice on our home page. We encourage you to refer to this policy on an ongoing basis so that you understand our current privacy policy. Unless stated otherwise, our current privacy policy applies to all information that we have about you and your account.
